5 **Planning Applications for Statutory Consideration**

1. **PL/2021/06197 Ford House Bottlesford Crossroads Northeast To Woodborough Broken Cross Bottlesford SN9 6LW : Replacement of decaying sash windows with broken springs with traditionally styled UPVC windows and construction of porch under existing porch roof footprint.**

Councillors discussed the planning application; Cllr TM had carried out a site visit and reported that the proposals were in keeping and balance for the property and whilst he would have preferred wood for the window frames recognised the perceived benefits of UPVC for ongoing maintenance. It was noted that this would “match” the windows of the neighbouring property. Clerk reported Cllr MM views on his behalf; no objections, enclosed modest size porch occupying similar footprint already there, proposed windows although not wood help with thermal performance of the property, although Cllr SD pointed out that it was not the window frames but the glass within that would provide better thermal capacity if replacing with double or triple glazing. All Councillors no issues with the detailed proposal and resolved “No objections”.

Action: Clerk to inform Wiltshire Council

6 Parishioners should be aware that the Hilcott Defibulator has been successfully moved, fully operational and is now situated at the entrance of Stitching’s Lane (opposite the Village Hall).
